Terms & Conditions for Receipt of Mulberry / Silkworm Germplasm

- a) The ownership of the designated germplasm shall solely rest on Central Silk Board / Central Sericultural Germplasm Resources Centre.
- b) The receiving Institute / University / Agency shall not seek any intellectual property rights over designated germplasm or related information.
- c) The receiving Institute / University / Agency shall share all the information regarding the protocol for in vitro multiplication of the designated germplasm with Central Silk Board / Central Sericultural Germplasm Resources Centre.
- d) The receiving Institute / University / Agency shall provide Central Silk Board access to their Premises to monitor adherence to the specified standards / norms for the use of designated germplasm.
- e) The receiving Institute / University / Agency shall make the designated germplasm and the related information available without restriction to Central Silk Board / Central Sericultural Germplasm Resources Centre.
- f) The receiving Institute / University / Agency shall not exploit the products / processes commercially outside its Project area.
- g) The intellectual properties shall be exploited by receiving Institute/ University/ Agency alone, and for no reason, whatsoever, shall be transferred to any other agency / individual.
- h) The Genetic Resources may be exchanged between CSB Institutes and outside agencies for the purpose of research under **MoU** or for the specific project in case of unreleased varieties / races, but for extension activities only through Dept. of Sericulture or on their recommendation in case of released varieties / races.
- i) In all Publications arising out of the designated germplasm proper acknowledgement of Central Silk Board / Central Sericultural Germplasm Resources Centre should be made.
