2. The tenders will be opened at **03.00 p.m. on 27.01.2021** in the administrative block in presence of Auction committee and the bidders who would like to present. Those who would like to participate should be present by 2.00 pm on 26.01.2021 at the spot.
3. The tenderer will have to deposit Rs.2,000/- (Rupees Two thousand) as Earnest Money Deposit (EMD) to participate in the tender auction in form of Demand Draft drawn in favour of The Director, CSGRC, Hosur. The tenders without EMD will be summarily be rejected.

TERMS & CONDITIONS

1. Tenderer should submit tender form in a sealed cover marked “Tender for Auction of coconuts” in person or by Registered post on or before **01.00 pm on 27.01.2021**. This office shall not be responsible for postal delay in receipt of tender.
2. The Tenderer will have to deposit Rs. 2,000 (Rs. Two thousand) as EMD to participate in the tender auction in form of Demand Draft drawn in favour of The Director, CSGRC, Hosur. The EMD can also be paid through Debit/credit card at this institute. The tenders without EMD will summarily be rejected.
3. The tenders will be opened at 3.00 p.m. on 27.01.2021 in the administrative block in presence of Auction committee and the bidders who would like to present.
4. Those who are interested in bidding can inspect the coconut orchard on any working day from 9.30 am to 4.00 p.m with the permission of office security.
5. The tendered rates for the coconut fruits should be equal or above the reserve price. The bids/tenders below the reserve price will not be accepted. The reserve price in sealed cover will be available with auction committee of this institute/centre.
6. The successful bidder shall deposit 25% of bid amount in form of DD drawn in favour of the Director, CSGRC Hosur within five days of receipt of Auction Award letter and balance 75% of bid amount in form DD drawn in favour of the Director, CSGRC Hosur within 15 days of receipt of Auction. EMD of the successful bidder will be forfeited if he/she fails to deposit the bid amounts and time frame as detailed above.
7. The EMD of unsuccessful bidder's EMD will be returned at the earliest.
8. Successful bidder should not sub-lease the tender and in the event of this office coming to know about the sub-leasing of the tender the right to harvest the coconuts will be withdrawn and amounts paid by him will be forfeited.
9. The tenderer shall harvest/pluck the coconuts only on working days from 10.00 a.m to 5.00 p.m.
10. The bidder should make arrangement for watch and ward for the coconut trees. The Institute will not be responsible for theft/pilferage or loss or any natural calamities of once tender is awarded and no money will be refunded in such case.
11. No child labour is permitted for plucking/harvesting the fruits and work in the campus.
12. Any dispute arising in this regard, the right of adjudication shall rest with the Director, CSGRC, Hosur and final decision will be ultimate and binding on all parties.
