

2. The rate should be quoted per meter / per roll basis inclusive of GST and should be valid for minimum of 90 days.
3. The supply orders will be placed after inspecting the suitability of the material in terms of quality and mesh dimentions.
4. Details required as per Bank Mandate form for online payment after satisfactory completion of supply of above materials in good condition.
5. Taxes / GST / Other statutory duties should be indicated separately.
