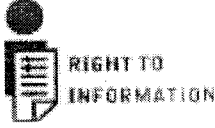

The scope of Certification is Conservation of mulberry and silkworm Germplasm, Research & Development, and Administration. The brief profile of CSGRC, Hosur is enclosed as **Annexure-I**.

TERMS AND CONDITIONS:

- The consultant / consultancy organization should have experience in the field of Quality Management Systems and should have assisted reputed organizations for ISO 9001: 2008 Consultancy. The quotation should include the list of companies assisted along with contact details.
- Consultant / consultancy organization should furnish their organization structure along with names, qualification & experience of the experts working for the Quality Management System.
- Rate should be quoted by the consultant / consultancy organization as per the format enclosed **Annexure-II**.
- Rate quoted should be valid for 120 days from date of opening of the quotation and should be inclusive of all charges like travel, accommodation, taxes etc.
- **The quotation should be accompanied by an EMD amount of 2% of total amount quoted in the form of demand draft** drawn in favour of Director, CSGRC, Hosur (T.N) failing which the quotation will not be accepted. EMD of the successful consultant will be refunded only after successful completion of the work i.e., after receipt of ISO 9001 : 2008 certificate from the Certification Agency. EMD will be forfeited if activities mentioned in Annexure-II are not carried out.

- No advance payment will be made. Payment will be made as per the schedule indicated below:-
 - 30% of the total quoted amount will be paid after completion of activities indicated in Category I of **Annexure-II**
 - 30% of the total quoted amount will be paid after completion of activities indicated in Category II of **Annexure-II**
 - 30% of the total quoted amount will be paid after completion of activities indicated in Category III of **Annexure-II**; and
 - Remaining 10% will be paid after receipt of ISO 9001: 2008 certificate from the Certification Agency.
- The selected consultant should give 5 % of the total quoted amount as Performance Bank Guarantee after receipt of work order till receipt of ISO 9001 : 2008 certificate from the Certification Agency.
