- (1) **EMD @ 2% on the quoted rate** in the form of Demand Draft favoring "The Director, Central Sericultural Germplasm Resources Centre" payable at Hosur. EMD will be refunded only after finalization of the bids, without interest.
- (2) **Validity : Rate quoted should be valid for 90 days.**
