TENDER NOTICE SEEKING QUOTATIONS FOR FARM YARD MANURE (FYM)

Sealed quotations are invited from eligible Parties for supply of well-decomposed Farm Yard Manure to Central Sericultural Germplasm Resources Centre, Central Silk Board, Govt. Of India, PB No.44, Thally Road, Hosur-635 109, Tamil Nadu. The party should quote the rate per MT (1000 kg) inclusive of FYM cost, transportation, loading and unloading charges at CSGRC Farm, Hosur.

Terms & Conditions for supply of FYM:

1. FYM should have the following quality standards at the time of delivery:

SN	Parameter	Purchase Norm
1	Total Quantity of FYM required	60 Metric Tonnes
2	Moisture level (25-30%)	On dropping the bulk FYM on floor, the particles should disintegrate into powder & not form clump.
3	Nitrogen Content (<i>dry weight basis</i>)	Min. 0.5%
4	P ₂ O ₅ Content (<i>dry weight basis</i>)	Min. 0.5%
5	K ₂ O Content (<i>dry weight basis</i>)	Min. 0.5%
6	Carbon: Nitrogen Ratio	Less than 20:1
7	Fodder spill over / grass / Soil etc., materials	Less than 5% by weight
8	Other conditions	Weighing Bridge Bill (<i>both empty & loaded is compulsory</i>) and free from plastics, glass pieces and stones, etc.,

2. Quotations should be submitted in a sealed envelope superscribed as "QUOTATION FOR FYM" and addressed to the Director, CSGRC, Central Silk Board, Govt. Of India, PB No.44, Thally Road, Hosur-635 109, Tamil Nadu.
3. Quotations will be received by this office upto **14.03.2022 till 2.00 p.m.** Quotations received after the due date and time will not be accepted.
4. Quotations can be submitted in person or by post or courier within the date and time.
5. Quotations will be opened by the Committee on **14.03.2022 at 3.30 p.m.**
6. The bidders or their authorized representatives, if they wish, may participate during opening of quotations. No separate intimation to bidders will be given in this regard.
7. Quotations not fulfilling the specifications will be summarily rejected without assigning any reasons thereof. The payment will not be made either in Cash or in advance. The party interested to quote the rates should supply the FYM on credit basis.
8. The rates quoted by the party must be valid upto 120 days.
9. The payment of the bill will be settled promptly but only on receipt of the materials as specified above and the materials will be rejected if found not in accordance with our specifications.
10. The successful bidders should be ready to supply FYM within a month at the same rate quoted by him. He should produce the FYM weighment slip for the conformity of the quantity supplied.
11. The rates should be excluding taxes and other Govt. Levies. The taxes and other Govt. Levies should be mentioned separately with % where such taxes are applicable.
12. The undersigned reserves the right to accept or reject in full or any part of the quotation without assigning any reasons thereof.
