- 1. Sealed and duly superscripted covers addressed to the Director, CSGRC, Hosur should be submitted on or before 03-06-2024 by 11.00 a.m. and the same will be opened at 11.30 a.m. on the same day.
- 2. This office is not responsible for the postal delay in case of tenders sent by post. No advance payment will be made by this office.
- 3. If the above specified dates declared as Holiday / Bandh days, the next working day with the same timings will holds good.
- 4. The rates quoted should be inclusive of all expenses upto work spot. Lowest rates will be considered for evaluation.
- 5. Tendered rates should be valid at least for a period of three months (90 days) from the date of opening.
- 6. The Director reserved the right to (i) accept / reject any or all the tenders either in full or part (b) cancel / withdraw tender notice & to change timings, date; (iii) withdraw / cancel work in part/ full at any time without assessing any reason whatsoever therefor.

- 7. To avoid repetition of terms & conditions, the tenderers should be familiar with the General conditions of contract for works, procedures, rules, etc., prevailing in CPWD (latest) & the same will be followed (after suitable modifications) to resolve any clarifications, confusions if any etc.
